Regarding implementation of a Probation supervision fee program.

DPCA Grant Proposal to DCJS - 11/15/72

Statewide Probation Training Center.

Area I (COPA) Intrastate Transfer Agreement - 6/14/94

A mutual operational guidelines developed by Area I Probation Directors.

Memorandum Report By DPCA General Counsel to All DPCA Field Staff - 11/16/94

Twenty legal questions and answers on Intrastate and Interstate transfers.

Violation of Probation Report Undated but Supported by 11 Pages of Legal References

Pertains to propriety of Parole or Probation revocation where Parole or Probationer is acquitted of criminal charges that are the basis of a revocation proceeding.

DPCA - Intra Memo Report - 7/8/85

Petition preparation for the Family Court by local Probation Department - a historical perspective and practice and opinion.

Report - 1/14/72

An outline of some of the effects of a criminal connection - e.g. employment, license, etc.

Report DPCA - Undated

Legal opinions on questions pertaining to "Certificate of Relief From Forfeitures and Disabilities".

Report of Counties in Central Region - 4/89

Policies and procedures for Intra-state transfer of Probation Departments.

State and Federal Aid to Probation - 6/1/72

Federal financial participation for Probation services in New York derived under Titles IV-A and XVI of the Social Security Act.

Report to the Presiding Justice of the Appellate Division, 4th Judicial Dept. and Administrator of the Former Judicial Conference (now O.C.A.) - 2/18/71

This report studied and made recommendations for improvements in the operation of the Family Court in Onondaga County. (One recommended feature was that petition preparations should not be done by Probation).

Study Report by DPCA on Felonization of Probation Caseload in NYS - 10/30/89

In depth study of increasing numbers of felony cases being sentenced to Probation. Examines the need for strengthening Probation services.

DPCA Report on a Study of Felony Cases in Which Probation was Terminated by Commitment - 12/61

A study of Probation revocation cases limited to felony cases; purpose to improve practice. It examined:

1. What problems were presented at point of sentencing;
2. What opportunity provided to probationer;
3. Reasons for termination of Probation.

DPCA Report on the Foster Home and Hostel Program - 9/61

It examines the rules that provided the machinery whereby the responsibility for certification of foster homes and hostels rested with Parole Board, the Court and local Probation (reimbursement by the state).

Report by National Council on Crime and Delinquency - 7/85

Study on fees for Probation services.

Records Retention and Disposition Schedule No. 15-CPD-1 By University of State of NY State Education Dept. - 6/76

Designed for local Probation Departments in disposing case files.

Prepared by DPCA MIS Unit for local Probation.

California Study - "Intensive Intervention: An Alternative to Institutionalization" By Eleanor Harlow - 1980's (?)

An in-depth study on community based programming vs. institutionalization and reviews the 1965 California State subsidy to county Probation Departments to set up "special supervision programs".

DPCA study and survey of local Probation practices regarding DWI fees.

DPCA Report on Contracting Out Probation Services - 10/83

Albany Symposium conducted by DPCA to explore issues to "contracting out" of Probation services and Probation related services.

Risk assessment guidelines and commentary regarding Sex Offender Registration Act.

DPCA State-Wide Probation Study - 2/15/73

Comprehensive statewide Probation salary study.

Study to clarify and emphasize legal responsibilities of Probation Officers in New York State.

Federal grant proposal to develop a system to provide J.D. and PINS data essential for purposes of planning, budgeting, training and program development and intake services.

Report by State Senator Catherine Abate - 3/98

Putting safety first: a look at Probation services in New York State.

DPCA Study on Use of Volunteers in Probation - 6/14/77

A survey and evaluation of Probation volunteer programs in New York State.
